## 1. WHO IS ELIGIBLE FOR FREE MEALS?

- a. All children in households receivirtgenefits from SNAP, FDPIR (Food Distribution Program on Indian Reservations) or TANF can get free meta regardles of your income.
- Foster children that are under the legal responsibility of a foster care agency or court are eligible for fr meals.

- 3. DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Use one Free and Reduced-Price School Meals Application for all students in your household. We cannot approx an application that is not complete, so be sure to fill out all required information. - 4. SHOULD I FILL OUT AN APPLICATION IF I RECEIVED A LETTER THIS SCHOOL YEAR SAYING MY CHILDREN ARE APPROVED FOR FREE MEALS? No, but please read the letter you got carefully. If any children in your household were missing from your eligibility notification, acctr623 445-5166 immediately.
- 5. CAN I APPLY ONLINE? Yes! You are encouraged to complete an online application instead of a parapplication if you are able the onlineapplication has the same requirements and will ask you for the satisformation as the paper application. - 8. WILL THE INFORMATION I GIVE BE CHECKED? Yes. We may also ask you to send written proof of the household income you report.

Our organization does not release information for immigrationed purposes in the usual course of operating the School Nutrition Programs.
- 12. WHAT IF MY INCOME IS NOT ALWAYS THE SAME? List the amount that yo<u>normally</u> receive. For example, if you normally make \$1000 each month, but you missed some work last month and only made \$900, put down that you made \$1000 per monthmally getnor overtime, include it, but do noticitude it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, your current income.

- 14. WE ARE IN THE MILITARY. DO WE REPORT OUR INCOME DIFFERENTLY? Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances fobasse housing, food, or clothing, it must also ibcluded as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any matches the pay resulting from deployment is also excluded from income.
